To whom it may concern:

The New York State Department of Environmental Conservation (DEC) is responsible for reviewing and issuing permits to authorize the application of pesticides to waters of the state. Depending on the project there may be several different permits required for each pesticide application and the permits will often only authorize the use of a specific pesticide product by label. The permits required may include Environmental Conservation Law (ECL) Article 15 Pesticide permits; ECL Article 24 Freshwater Wetlands permits; ECL Article 25 Tidal Wetlands permits; ECL Article 14, Title 27 Wild, Scenic and Recreational Rivers permits; or ECL Article 17 State Pollution Discharge Elimination System (SPDES) permits or coverage by the SPDES Pesticide General Permit.

DEC has learned that certain pesticides, that it has previously authorized for use through many of the permits referenced above, have labels that have been updated by the manufacturer and the United States Environmental Protection Agency (USEPA) to reflect a new company name, new USEPA Registration Number, and new USEPA Establishment Number. There have been no changes in the pesticide product itself or in the way the pesticide is applied. Therefore, there are no anticipated environmental impacts from this change in labeling. Some permits may have been updated to reflect the newly labeled pesticide products, but others may not have, creating a situation where the newly labeled pesticide products are not authorized by the permit(s).

The older labeled pesticide products were sold by Applied Biochemists, 1400 Bluegrass Lakes Parkway, Alpharetta GA 30004, while the newer labeled pesticide products will be sold by SePRO Corporation 11550 North Meridian Street, Suite 600 Carmel, IN 46032. The table below cross-references the USEPA registration number for the older labeled pesticide products with the newly labeled pesticide products.

The newly labeled pesticide products have been, or will be, registered with DEC. The newly labeled pesticide products that are not yet registered for use in New York State are not authorized until they are registered with DEC. Once the newly labeled pesticide products are registered for use in New York, this letter authorizes the use of the newly labeled pesticide products (SePRO) listed in the above table, wherever an existing DEC permit includes authorization for a product with the same name as the older labeled pesticide products listed in the above table. However, there will be an interim period in which both the older labeled pesticide products and the newly labeled pesticide products could be authorized for use. The older labeled pesticide products may continue to be used until the registration expires. The permittee must maintain a copy of this letter with the permit and a copy of the applicable pesticide labels.

This letter does not modify existing permits in any other manner, nor does it authorize substitutions of any other pesticide products.
